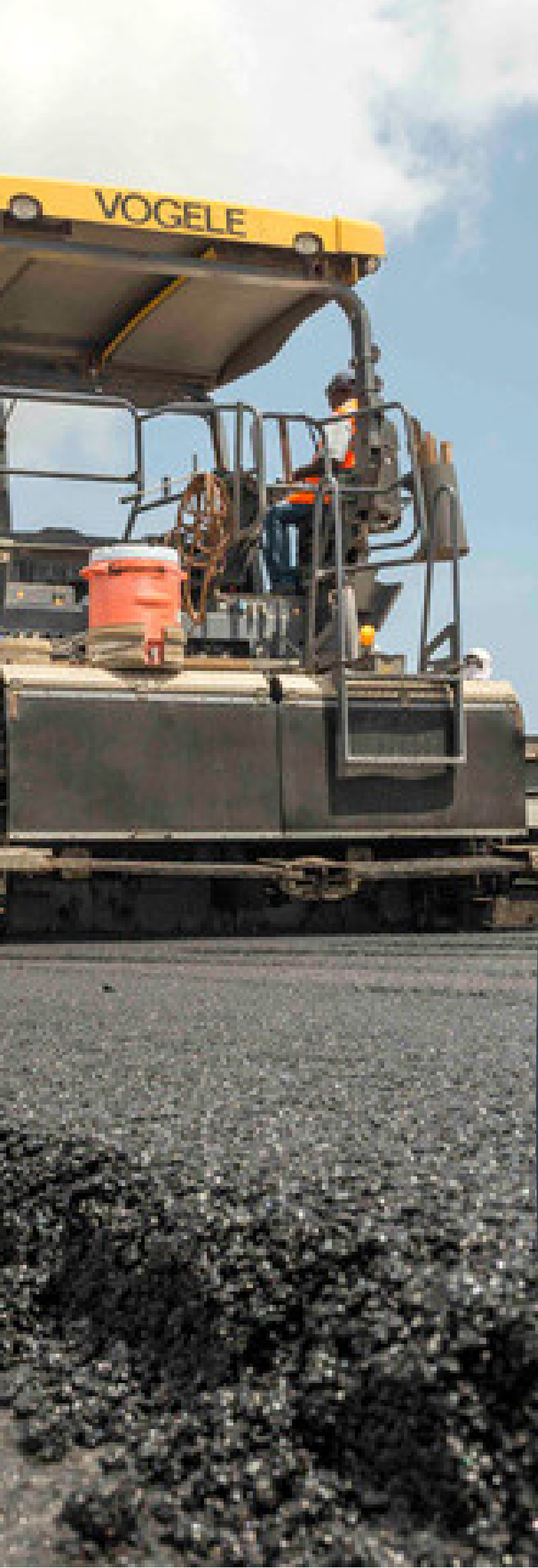

THE OBJECTS FOR WHICH THE COMPANY IS ESTABLISHED

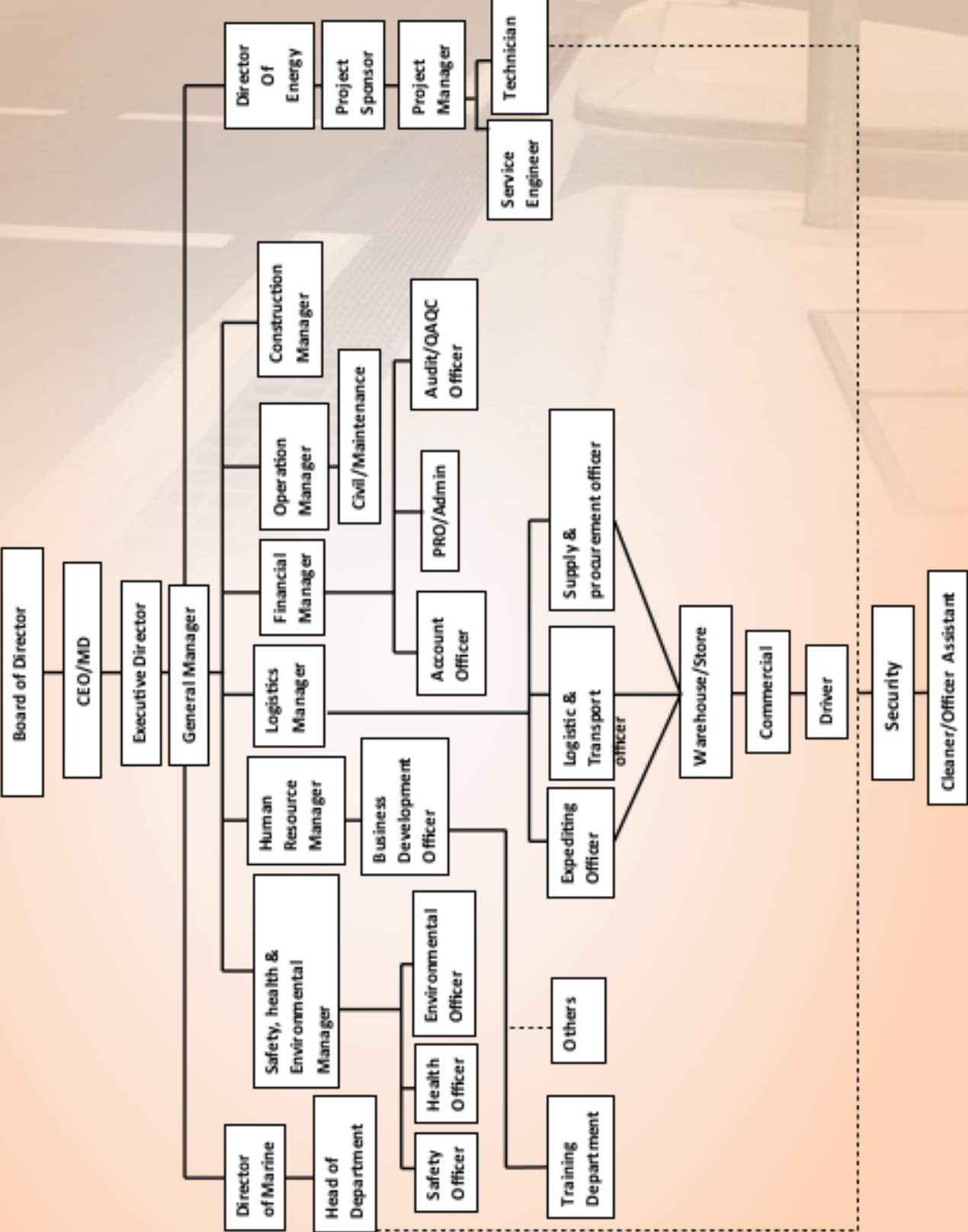
